Declarant declares that there are no additional or different limitations, restrictions, covenants or restrictions with respect to the property annexed pursuant to this Thirteenth Amendment from the property originally subject to the Declaration.
- 2. **Effective Date.** The effective date hereof shall be the date of recording of this Thirteenth Amendment in the Records of Spokane County, Washington. Declarant hereby certifies that this Thirteenth Amendment has been adopted in the manner required by the Declaration.
